## Terms & Conditions

1. Items need to be picked up within 2 weeks of being pulled unless stated otherwise.
2. All core engines and transmissions must be drained or an EPA charge will be assessed.
3. All returns must be accompanied by sales receipt. Cores must come back assembled as picked-up with all parts.
4. Exchange parts must be turned in at the time of purchase or there will be a core charge. The core charge will be refunded if the exchange parts are brought in unless otherwise specified.
5. Engines and transmissions come with a 30-day limited warranty unless otherwise specified on invoice. Engines are guaranteed against rod knock, cracked block, and excessive smoking. Engine accessories are not guaranteed. There is no guarantee for labor to install or remove. Timing belts, water pumps, oil filter, oil pump, spark plugs, and all drive belts must be changed or warranty is void.
6. Transmissions are guaranteed to work properly. Gears are guaranteed to be in good condition at the time of purchase. There is no responsibility for improper installation or usage after time of purchase. There is no guarantee for labor to install or remove.
7. Rear ends are guaranteed to work properly; gears are guaranteed to be in good condition. Bearings are guaranteed not to be noisy at time of purchase. There is no guarantee for labor to install or remove. We do not guarantee axle seals, pinion seals, or brake hardware.
8. Radiators are guaranteed not to leak at time of purchase.
9. Starters and alternators are guaranteed to work at time of purchase. There is no responsibility for improper installation, faulty voltage regulator, or poor electrical connections by customer. There is no refund on electrical parts.
10. No refund on "special ordered" parts.
11. We reserve the right to REPLACE parts purchased before making a cash refund.
12. Claims for adjustment due to defective parts must be made within 48 hours of time of purchase unless other specific agreements were made at time of purchase.
13. Parts not defective which are returned by customer for credit are subject to acceptance by dismantler and are subject to a 35% handling charge if accepted. Parts other than those originally sold or which have been altered or damaged are not acceptable for return. Body sections which have been cut off to-order are not refundable.
14. Engines and cylinder heads have heat tabs installed on them. If the center of the heat tab is melted out or the heat tab is removed, the guarantee is void. Cylinder heads are guaranteed against crack ONLY.
15. All used merchandise must be inspected by buyer for defects or safety hazards. Seller in no way guarantees or warrants used merchandise for apparent or non-apparent safety hazards and affirmatively states that used merchandise sold may have safety hazards and it is the responsibility of buyer to inspect for actual or latent safety hazards or hire an expert to so inspect.
16. Buyer affirms that before entering into this agreement, the seller requested that buyer examine the goods to ascertain whether there were defects in the goods which would make them unacceptable to buyer; that seller afforded to buyer an adequate opportunity to make such examination before buyer entered into this agreement and that buyer has examined the goods as fully as buyer desires for the purpose of determining whether there are defects.
17. We do not refund deposits. All sales are final. No returns on airbags. All claims and returned goods must be accompanied by this invoice.
18. The warranty does not apply if parts are broken apart or if motors and/or transmissions are not installed by a registered repair facility, except for this limited warranty such used parts sold "AS IS" with all faults. There are no other expressed warranties and no implied warranties including the implied warranty and merchantability. Warranty starts from date of invoice unless otherwise specified.
19. We will certify mileage on used engines when information is available.
20. No labor allowance on installation of parts.
21. All claims and returned items must be accompanied by original receipt/invoice.
22. Body parts and glass are sold as-is.
23. All sales subject to terms and conditions stated above.
